SUBJECT: Proposed Increase to Annual Device Registration Fees

The San Mateo County Board of Supervisors will consider amending Section 5.124.020 of the San Mateo County Code during their November 12, 2024, meeting. Section 5.124.020 authorizes the County Sealer of Weights and Measures to charge an annual device registration fee to offset program costs associated with the inspection and testing of commercial scales, gas pumps, taxis, and other commercial weighing and measuring devices. The proposal is to increase this fee to the maximum allowed by Section 12240 of California's Business and Professions Code (BPC) thereby making San Mateo County's device registration fees the same as neighboring Bay Area County Weights and Measures Departments. We are proposing to lower the late penalty from 100% to 50% and eliminate the location fee for non-fixed location scales brought into the office for testing.

BPC Section 12240 authorizes county boards of supervisors to charge device registration fees and specifies the maximum rate counties may charge. This regulation was amended in October 2023 to increase the maximum allowable fee for certain devices. The proposed amendment of 5.124.020 will generate an additional \$152,900 to supplement \$375,156 in revenue against \$614,212 in program costs.

If adopted, the proposed fees will be effective January 3, 2024. A chart outlining the proposed fee schedule is attached.

Meetings begin at 9:00 a.m. and are held in the Board of Supervisors Chambers at 500 County Center, Redwood City, California.
